#### 1 Innovative Product Evaluated<sup>1</sup>

1.1 5/16" T-Star Washer Head SPAX PowerLags Fasteners

#### 2 Product Description and Materials




Figure 1. 5/16" T-Star Washer Head SPAX PowerLags Fasteners for Multi-Ply Assemblies (in)

2.1 The innovative product evaluated in this report is shown in **Figure 1**.

- 2.2 SPAX PowerLags Fasteners are manufactured with carbon steel grade 1022 or 10B21 wire conforming to ASTM A510 or grade 17MnB3 or 19MnB4 wire conforming to DIN 1654.
- 2.3 SPAX PowerLags Fasteners are manufactured using a standard cold-formed process, followed by a heat-treating process. Allowable bending yield and critical dimensions are found in **Figure 1** and **Table 1**.
  - 2.3.1 SPAX PowerLags Fasteners heads are T-40 T-Star drive.
  - 2.3.2 SPAX PowerLags Fasteners have a gimlet point.





- 2.4 SPAX PowerLags Fasteners are available with proprietary coatings:
  - 2.4.1 Interior Grade: Yellow Electro-Zinc with Wax meeting ASTM F1941.
  - 2.4.2 *Exterior Grade:* Proprietary HCR<sup>™</sup> that exceeds the protection provided by code approved hot-dipped galvanized coatings meeting ASTM A153, as specified in <u>IBC Section 2304.10.6</u><sup>2</sup> and <u>IRC Section R304.3</u>.<sup>3</sup>
    - 2.4.2.1 HCR coating is approved for use in ground contact pressure treated wood (Alkaline Copper Quaternary Type D, ACQ-D) in general construction (freshwater) applications.
    - 2.4.2.2 HCR coated fasteners are approved for use in fire-retardant treated lumber, provided the conditions set forth by the fire-retardant treated lumber manufacturer be met, including appropriate strength reductions.
  - 2.4.3 <sup>5</sup>/<sub>16</sub>" T-Star Washer Head SPAX PowerLags Fasteners, evaluated in this report are set forth in **Table 1**.

3. Determined in accordance with methods specified in ASTM F1575, based on minor thread diameter using a five percent (5%) offset of the load displacement curves developed from bending tests.

4. Fastener dimensions are as measured on uncoated fasteners.

2.5 As needed, review material properties for design in **Section 6** and the regulatory evaluation in **Section 8**.

#### 3 Definitions<sup>4</sup>

- 3.1 <u>New Materials</u><sup>5</sup> are defined as building materials, equipment, appliances, systems, or methods of construction, not provided for by prescriptive and/or legislatively adopted regulations, known as alternative materials.<sup>6</sup> The <u>design strength</u> and permissible stresses shall be established by tests<sup>7</sup> and/or engineering analysis.<sup>8</sup>
- 3.2 <u>Duly authenticated reports</u><sup>9</sup> and <u>research reports</u><sup>10</sup> are test reports and related engineering evaluations that are written by an <u>approved agency</u><sup>11</sup> and/or an <u>approved source</u>.<sup>12</sup>
  - 3.2.1 These reports utilize intellectual property and/or trade secrets to create public domain material properties for commercial end-use.
    - 3.2.1.1 This report protects confidential Intellectual Property and trade secretes under the regulation, <u>18.US.Code.90</u>, also known as <u>Defend Trade Secrets Act of 2016</u> (DTSA).<sup>13</sup>
- 3.3 An approved agency is *"approved"* when it is <u>ANAB ISO/IEC 17065 accredited</u>. DrJ Engineering, LLC (DrJ) is accredited and listed in the <u>ANAB directory</u>.





- 3.4 An <u>approved source</u> is *"approved"* when a professional engineer (i.e., <u>Registered Design Professional</u>, hereinafter <u>RDP</u>) is properly licensed to transact engineering commerce. The regulatory authority governing approved sources is the <u>state legislature</u> via its professional engineering regulations.<sup>14</sup>
- 3.5 Testing and/or inspections conducted for this <u>duly authenticated report</u> were performed by an <u>ISO/IEC 17025</u> <u>accredited testing laboratory</u>, an <u>ISO/IEC 17020 accredited inspection body</u>, and/or a licensed <u>RDP</u>.
  - 3.5.1 The <u>Center for Building Innovation</u> (CBI) is <u>ANAB<sup>15</sup> ISO/IEC 17025</u> and <u>ISO/IEC 17020</u> accredited.
- 3.6 The regulatory authority shall <u>enforce</u><sup>16</sup> the specific provisions of each legislatively adopted regulation. If there is a non-conformance, the specific regulatory section and language of the non-conformance shall be provided in <u>writing</u><sup>17</sup> stating the nonconformance and the path to its cure.
- 3.7 The regulatory authority shall accept <u>duly authenticated reports</u> from an <u>approved agency</u> and/or an <u>approved</u> <u>source</u> with respect to the quality and manner of use of new materials or assemblies as provided for in regulations regarding the use of alternative materials, designs, or methods of construction.<sup>18</sup>
- 3.8 ANAB is an <u>International Accreditation Forum</u> (IAF) <u>Multilateral Recognition Arrangement</u> (MLA) signatory. Therefore, recognition of certificates and validation statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA with the appropriate scope shall be approved.<sup>19</sup> Thus, all ANAB ISO/IEC 17065 <u>duly authenticated reports</u> are approval equivalent,<sup>20</sup> and can be used in any country that is an MLA signatory found at this link: <u>https://iaf.nu/en/recognised-abs/</u>
- 3.9 Approval equity is a fundamental commercial and legal principle.<sup>21</sup>

- 6.1.2 Unless otherwise noted, adjustment of the design stresses for duration of load shall be in accordance with the applicable code.

  - 6.2.1 SPAX PowerLags Fasteners for Multi-Ply Truss and Sawn Lumber Assemblies
    - 6.2.1.1 Design values are set forth in **Table 2**.

1. Fastener length is measured from the underside of the head to the tip.

2. Thread length includes tip (see Figure 1).

3. For wood species with an assigned specific gravity between 0.42 and 0.50, use the tabulated values for specific gravity of 0.42. For wood species with an assigned specific gravity greater than 0.50, use the tabulated values for specific gravity of 0.50.

4. Allowable loads are based on a load duration factor  $C_D = 1.0$  and shall be multiplied by all applicable adjustment factors per the NDS.

5. The tabulated allowable design loads may be applied to either side of the beam (head or point side of the fastener). Where loads are applied to both sides of the beam simultaneously, the load applied to the either side of beam shall not exceed the tabulated load for the corresponding side.

6. All design values are also applicable to top-loaded assemblies with even loading across the width of the entire assembly. For top-loaded members, fasteners shall be installed in two (2) rows with a maximum distance of 32" o.c. between fasteners in the same row.




Figure 2. SPAX PowerLags Fasteners Assemblies for Truss and Sawn Lumber

1. Fastener length is measured from the underside of the head to the tip.

2. Thread length includes tip; see Figure 1.

3. Wood members shall have an equivalent specific gravity of 0.50 or greater.

4. Allowable loads are based on a load duration factor C<sub>D</sub> = 1.0 and shall be multiplied by all applicable adjustment factors per the NDS.

5. The tabulated allowable design loads may be applied to either side of the beam (head or point side of the fastener). Where loads are applied to both sides of the beam simultaneously, the load applied to the either side of beam shall not exceed the tabulated load for the corresponding side.

6. All design values are also applicable to top-loaded assemblies with even loading across the width of the entire assembly. For top-loaded members up to 18" deep, fasteners shall be installed in two (2) rows with a maximum distance of 24" o.c. between fasteners in the same row. Use three (3) rows for members deeper than 18".




Figure 3. SCL Assembly Configurations





#### 6.3 Spacing, Edge Distance, and End Distance




Figure 4. SPAX PowerLags Fasteners Spacing

6.3.1 SPAX PowerLags Fasteners spacing, edge distances, and end distances shall be as specified in **Table 4**. See **Figure 4** for additional details.

- 1. Edge distances, end distances, and spacing of fasteners shall be sufficient to prevent splitting of the wood, or as shown in this table, whichever is more restrictive.
- 2. Values for "Spacing between Rows of Fasteners-Staggered" apply where the fasteners in adjacent rows are offset by one-half of the "Spacing between Fasteners in a Row".

6.4 Where the application falls outside of the performance evaluation, conditions of use, and/or installation requirements set forth herein, alternative techniques shall be permitted in accordance with accepted engineering practice and experience. This includes but is not limited to the following areas of engineering: mechanics or materials, structural, building science, and fire science.





#### 7 Certified Performance<sup>24</sup>

- 7.1 All construction methods shall conform to accepted engineering practices to ensure durable, livable, and safe construction and shall demonstrate acceptable workmanship reflecting journeyman quality of work of the various trades.<sup>25</sup>
- 7.2 The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur.<sup>26</sup>

#### 8 Regulatory Evaluation and Accepted Engineering Practice

- 8.1 SPAX PowerLags Fasteners comply with the following legislatively adopted regulations and/or accepted engineering practice for the following reasons:
  - 8.1.1 SPAX PowerLags Fasteners were evaluated to determine their ability to provide multi-ply attachment in trusses, sawn lumber, and engineered wood applications.
  - 8.1.2 Corrosion resistance in accordance with ASTM B117 and ASTM G85, Annex A5.
- 8.2 Any building code, regulation and/or accepted engineering evaluations (i.e., <u>research reports</u>, <u>duly</u> <u>authenticated reports</u>, etc.) that are conducted for this Listing were performed by DrJ, which is an <u>ISO/IEC</u> <u>17065 accredited certification body</u> and a professional engineering company operated by <u>RDP</u> or <u>approved</u> <u>sources</u>. DrJ is qualified<sup>27</sup> to practice product and regulatory compliance services within its <u>scope of</u> <u>accreditation and engineering expertise</u>,<sup>28</sup> respectively.
- 8.3 Engineering evaluations are conducted with DrJ's ANAB <u>accredited ICS code scope</u> of expertise, which is also its areas of professional engineering competence.
- 8.4 Any regulation specific issues not addressed in this section are outside the scope of this report.

#### 9 Installation

- 9.1 Installation shall comply with the approved construction documents, the manufacturer installation instructions, this report, and the applicable building code.
- 9.2 In the event of a conflict between the manufacturer installation instructions and this report, contact the manufacturer for counsel on the proper installation method.
- 9.3 Installation Procedure
  - 9.3.1 The <sup>5</sup>/<sub>16</sub>" T-Star Washer Head SPAX PowerLags Fasteners must be installed with a <sup>1</sup>/<sub>2</sub>" (12.7 mm), low rpm/high torque electric drill (450 rpm) or impact wrench using the appropriate driver bit.
    - 9.3.1.1 Do not overdrive.
    - 9.3.1.2 In the event a fastener is overdriven, contact the manufacturer for counsel on steps to take and, if needed, a repair to be made.
  - 9.3.2 Install SPAX PowerLags Fasteners so that as many threads fully engage the main member (final member in multi-ply assembly) as possible when head is fully seated against the lumber.
  - 9.3.3 Lead holes are not required.
  - 9.3.4 For applications outside the scope of this report, an engineered design is required.





#### **10** Substantiating Data

- 10.1 Testing has been performed under the supervision of a professional engineer and/or under the requirements of ISO/IEC 17025 as follows:
  - 10.1.1 Lateral resistance testing in accordance with ASTM D1761
- 10.2 Information contained herein may include the result of testing and/or data analysis by sources that are <u>approved agencies</u>, <u>approved sources</u>, and/or an <u>RDP</u>. Accuracy of external test data and resulting analysis is relied upon.
- 10.3 Where applicable, testing and/or engineering analysis are based upon provisions that have been codified into law through state or local adoption of regulations and standards. The developers of these regulations and standards are responsible for the reliability of published content. DrJ's engineering practice may use a regulation-adopted provision as the control. A regulation-endorsed control versus a simulation of the conditions of application to occur establishes a new material as <u>being equivalent</u> to the regulatory provision in terms of quality, <u>strength</u>, effectiveness, <u>fire resistance</u>, durability, and safety.
- 10.4 The accuracy of the provisions provided herein may be reliant upon the published properties of raw materials, which are defined by the grade mark, grade stamp, mill certificate, or <u>duly authenticated reports</u> from <u>approved</u> <u>agencies</u> and/or <u>approved sources</u> provided by the supplier. These are presumed to be minimum properties and relied upon to be accurate. The reliability of DrJ's engineering practice, as contained in this <u>duly</u> <u>authenticated report</u>, may be dependent upon published design properties by others.

#### 10.5 Testing and Engineering Analysis:

- 10.5.1 The strength, rigidity, and/or general performance of component parts and/or the integrated structure are determined by suitable tests that simulate the actual conditions of application that occur and/or by accepted engineering practice and experience.<sup>29</sup>
- 10.6 Where additional condition of use and/or regulatory compliance information is required, please search for SPAX PowerLags Fasteners on the <u>DrJ Certification website</u>.

#### **11 Findings**

- 11.1 As outlined in **Section 6**, SPAX PowerLags Fasteners have performance characteristics that were tested and/or meet applicable regulations. In addition, they are suitable for use pursuant to its specified purpose.
- 11.2 When used and installed in accordance with this duly authenticated report and the manufacturer installation instructions, SPAX PowerLags Fasteners shall be approved for the following applications:
  - 11.2.1 SPAX PowerLags Fasteners with HCR coating are approved for use in ground contact pressure-treated wood (ACQ) in general construction (freshwater) applications.
  - 11.2.2 HCR coated fasteners are approved for use in fire-retardant treated lumber, provided the conditions set forth by the fire-retardant treated lumber manufacturer be met, including appropriate strength reductions.
- 11.3 Unless exempt by state statute, when SPAX PowerLags Fasteners are to be used as a structural and/or building envelope component in the design of a specific building, the design shall be performed by an <u>RDP</u>.
- 11.4 Any application specific issues not addressed herein can be engineered by an <u>RDP</u>. Assistance with engineering is available from Altenloh, Brinck & Company U.S., Inc.
- 11.5 IBC Section 104.2.3 (IRC Section R104.2.2 and IFC Section 104.2.3<sup>30</sup> are similar) in pertinent part state:

**104.2.3 Alternative Materials, Design and Methods of Construction and Equipment.** The provisions of this code are not intended to prevent the installation of any material or to prohibit any design or method of construction not specifically prescribed by this code, provided that any such alternative is not specifically prohibited by this code and has been approved.





- 11.6 Approved:<sup>31</sup> Building regulations require that the building official shall accept duly authenticated reports.<sup>32</sup>
  - 11.6.1 An <u>approved agency</u> is "approved" when it is <u>ANAB ISO/IEC 17065 accredited</u>.
  - 11.6.2 An <u>approved source</u> is *"approved"* when an <u>RDP</u> is properly licensed to transact engineering commerce.
  - 11.6.3 Federal law, <u>Title 18 US Code Section 242</u>, requires that, where the alternative product, material, service, design, assembly, and/or method of construction is not approved, the building official shall respond in writing, stating the reasons why the alternative was not approved. Denial without written reason deprives a protected right to free and fair competition in the marketplace.
- 11.7 DrJ is a licensed engineering company, employs licensed <u>RDP</u>s and is an <u>ANAB Accredited Product</u> <u>Certification Body</u> – <u>Accreditation #1131</u>.
- 11.8 Through the <u>IAF Multilateral Arrangement</u> (MLA), this <u>duly authenticated report</u> can be used to obtain product approval in any <u>jurisdiction</u> or <u>country</u> because all ANAB ISO/IEC 17065 <u>duly authenticated reports</u> are equivalent.<sup>33</sup>

#### 12 Conditions of Use

- 12.1 Material properties shall not fall outside the boundaries defined in Section 6.
- 12.2 As defined in **Section 6**, where material and/or engineering mechanics properties are created for load resisting design purposes, the resistance to the applied load shall not exceed the ability of the defined properties to resist those loads using the principles of accepted engineering practice.
- 12.3 When required by adopted legislation and enforced by the <u>building official</u>, also known as the Authority Having Jurisdiction (AHJ) in which the project is to be constructed:
  - 12.3.1 Any calculations incorporated into the construction documents shall conform to accepted engineering practice and, when prepared by an <u>approved source</u>, shall be approved when signed and sealed.
  - 12.3.2 This report and the installation instructions shall be submitted at the time of <u>permit</u> application.
  - 12.3.3 This innovative product has an internal quality control program and a third-party quality assurance program.
  - 12.3.4 At a minimum, this innovative product shall be installed per **Section 9** of this report.
  - 12.3.5 The review of this report by the AHJ shall comply with IBC Section 104.2.3.2 and IBC Section 105.3.1.
  - 12.3.6 This innovative product has an internal quality control program and a third party quality assurance program in accordance with <u>IBC Section 104.7.2</u>, <u>IBC Section 110.4</u>, <u>IBC Section 1703</u>, <u>IRC Section R104.7.2</u>, and <u>IRC Section R109.2</u>.
  - 12.3.7 The application of this innovative product in the context of this report is dependent upon the accuracy of the construction documents, implementation of installation instructions, inspection as required by <u>IBC</u> <u>Section 110.3</u>, <u>IRC Section R109.2</u>, and any other regulatory requirements that may apply.
- 12.4 The approval of this report by the AHJ shall comply with <u>IBC Section 1707.1</u>, where legislation states in part, *"the <u>building official</u> shall make, or cause to be made, the necessary tests and investigations; or the <u>building</u> <u>official</u> shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in <u>Section 104.2.3</u>", all of <u>IBC Section 104</u>, and <u>IBC Section 105.3</u>.*
- 12.5 <u>Design loads</u> shall be determined in accordance with the regulations adopted by the jurisdiction in which the project is to be constructed and/or by the building designer (i.e., <u>owner</u> or <u>RDP</u>).
- 12.6 The actual design, suitability, and use of this report for any particular building, is the responsibility of the owner or the authorized agent of the <u>owner</u>.

#### 1 Legislation that Authorizes AHJ Approval

- 1.1 **Fair Competition:** <u>State legislatures</u> have adopted Federal regulations for the examination and approval of building code referenced and alternative products, materials, designs, services, assemblies, and/or methods of construction that:
  - 1.1.1 Advance innovation.
  - 1.1.2 Promote competition so all businesses have the opportunity to compete on price and quality in an open market on a level playing field unhampered by anticompetitive constraints.
  - 1.1.3 Benefit consumers through lower prices, better quality, and greater choice.
- 1.2 **Adopted Legislation:** The following local, state, and federal regulations affirmatively authorize products to be approved by AHJs, delegates of building departments, and/or delegates of an agency of the federal government:
  - 1.2.1 Interstate commerce is governed by the <u>Federal Department of Justice</u> to encourage the use of innovative products, materials, designs, services, assemblies, and/or methods of construction. The goal is to *"protect economic freedom and opportunity by promoting free and fair competition in the marketplace"*.
  - 1.2.2 <u>Title 18 US Code Section 242</u> affirms and regulates the right of individuals and businesses, to freely and fairly have new products, materials, designs, services, assemblies, and/or methods of construction approved for use in commerce. Disapproval of alternatives shall be based upon non-conformance with respect to specific provisions of adopted legislation and shall be provided in writing <u>stating the reasons</u> why the alternative was not approved, with reference to the specific legislation violated.
  - 1.2.3 The <u>federal government</u> and each state have a <u>public records act</u>. In addition, each state also has legislation that mimics the federal <u>Defend Trade Secrets Act 2016</u> (DTSA),<sup>34</sup> where providing test reports, engineering analysis, and/or other related IP/TS is subject to <u>prison of not more than ten years</u><sup>35</sup> and/or a <u>\$5,000,000 fine or three (3) times the value of</u><sup>36</sup> the Intellectual Property (IP) and Trade Secrets (TS).
    - 1.2.3.1 Compliance with public records and trade secret legislation requires approval through the use of Listings, certified reports, Technical Evaluation Reports, duly authenticated reports, and/or research reports prepared by approved agencies and/or approved sources.
  - 1.2.4 For <u>new materials</u><sup>37</sup> that are not specifically provided for in any regulation, the <u>design strengths and</u> <u>permissible stresses</u> shall be established by <u>tests</u>, where <u>suitable load tests simulate the actual loads and</u> <u>conditions of application that occur</u>.
  - 1.2.5 The <u>design strengths and permissible stresses</u> of any structural material shall <u>conform</u> to the specifications and methods of design using accepted engineering practice.<sup>38</sup>
  - 1.2.6 The commerce of <u>approved sources</u> (i.e., registered PEs) is regulated by <u>professional engineering</u> <u>legislation</u>. Professional engineering <u>commerce shall always be approved</u> by AHJs, except where there is evidence provided in writing, that specific legislation have been violated by an individual registered PE.
  - 1.2.7 The AHJ shall accept <u>duly authenticated reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in <u>IBC Section 104.2.3</u>.<sup>39</sup>





- 1.3 Approved<sup>40</sup> by Los Angeles: The Los Angeles Municipal Code (LAMC) states in pertinent part, that the provisions of LAMC are not intended to prevent the use of any material, device, or method of construction, not specifically prescribed by LAMC. The Department shall use Part III, Recognized Standards in addition to Part II, Uniform Building Code Standards of <u>Division 35</u>, <u>Article 1</u>, <u>Chapter IX</u> of the LAMC in evaluation of products for approval where such standard exists for the product or the material and may use other approved standards that apply. Whenever tests or certificates of any material or fabricated assembly are required by <u>Chapter IX</u> of the LAMC, such tests or certification shall be made by a <u>testing agency</u> approved by the Superintendent of Building to conduct such tests or provide such certifications. The testing agency shall publish the scope and limitation(s) of the listed material or fabricated assembly.<sup>41</sup> The Superintendent of Building <u>Approved Testing Agency Roster</u> is provided by the Los Angeles Department of Building and Safety (LADBS). The Center for Building Innovation (CBI) Certificate of Approval License is <u>TA24945</u>. Tests and certifications found in a <u>DrJ Listing</u> are LAMC approved. In addition, the Superintendent of Building shall accept <u>duly authenticated reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in the <u>California Building Code, CBC Section 1707.1</u>.<sup>42</sup>
- 1.4 Approved by Chicago: The Municipal Code of Chicago (MCC) states in pertinent part that an <u>approved</u> agency is a Nationally Recognized Testing Laboratory (NRTL) acting within its recognized scope and/or a certification body accredited by the <u>American National Standards Institute</u> (ANSI) acting within its accredited scope. Construction materials and test procedures shall conform to the applicable standards listed in the MCC. Sufficient technical data shall be submitted to the building official to substantiate the proposed use of any product, material, service, design, assembly, and/or method of construction, not specifically provided for in the MCC. This technical data shall consist of <u>research reports</u> from <u>approved sources</u> (i.e., MCC defined <u>approved agencies</u>).
- 1.5 Approved by New York City: The 2022 NYC Building Code (NYCBC) states in part that an approved agency shall be deemed<sup>43</sup> an approved testing agency via <u>ISO/IEC 17025</u> accreditation, an approved inspection agency via <u>ISO/IEC 17020 accreditation</u>, and an approved product evaluation agency via <u>ISO/IEC 17065</u> accreditation. Accrediting agencies, other than federal agencies, must be members of an internationally recognized cooperation of laboratory and inspection accreditation bodies subject to a mutual recognition agreement<sup>44</sup> (i.e., <u>ANAB</u>, <u>International Accreditation Forum</u> also known as IAF, etc.).
- 1.6 **Approved by Florida:** <u>Statewide approval</u> of products, methods, or systems of construction, shall be approved without further evaluation by:
  - 1.6.1 A certification mark or listing of an approved certification agency
  - 1.6.2 A test report from an approved testing laboratory
  - 1.6.3 A product evaluation report based upon testing or comparative or rational analysis, or a combination thereof, from an approved product evaluation entity
  - 1.6.4 A product evaluation report based upon testing, comparative or rational analysis, or a combination thereof, developed, signed, and sealed by a professional engineer or architect, licensed in Florida.
  - 1.6.5 For local product approval, products or systems of construction shall demonstrate compliance with the structural wind load requirements of the Florida Building Code (FBC) through one of the following methods:
    - 1.6.5.1 A certification mark, listing, or label from a commission-approved certification agency indicating that the product complies with the code.
    - 1.6.5.2 A test report from a commission-approved testing laboratory indicating that the product tested complies with the code.
    - 1.6.5.3 A product evaluation report based upon testing, comparative or rational analysis, or a combination thereof, from a commission-approved product evaluation entity, which indicates that the product evaluated complies with the code.





- 1.6.5.4 A product evaluation report or certification based upon testing, comparative, or rational analysis, or a combination thereof, developed, signed, and sealed by a Florida professional engineer or Florida registered architect, which indicates that the product complies with the code.
- 1.6.5.5 A statewide product approval issued by the Florida Building Commission.
- 1.6.6 The <u>Florida Department of Business and Professional Regulation</u> (DBPR) website provides a listing of companies certified as a <u>Product Evaluation Agency</u> (i.e., EVLMiami 13692), a <u>Product Certification</u> <u>Agency</u> (i.e., CER10642), and as a <u>Florida Registered Engineer</u> (i.e., ANE13741).
- 1.7 **Approved by Miami-Dade County (i.e., Notice of Acceptance [NOA]):** A Florida statewide approval is an NOA. An NOA is a Florida local product approval. By Florida law, Miami-Dade County shall accept the statewide and local Florida Product Approval as provided for in Florida legislation <u>553.842</u> and <u>553.8425</u>.
- 1.8 **Approved by New Jersey:** Pursuant to the 2018 Building Code of New Jersey in <u>IBC Section 1707.1</u> <u>General</u>,<sup>45</sup> it states: "In the absence of approved rules or other approved standards, the building official shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in the administrative provisions of the Uniform Construction Code (<u>N.J.A.C. 5:23</u>)".<sup>46</sup> Furthermore N.J.A.C 5:23-3.7 states: "Municipal approvals of alternative materials, equipment, or methods of construction".
  - 1.8.1 **Approvals:** Alternative materials, equipment, or methods of construction shall be approved by the appropriate subcode official, provided the proposed design is satisfactory and that the materials, equipment, or methods of construction are suitable for the intended use and are at least the equivalent in quality, strength, effectiveness, fire resistance, durability, and safety of those conforming with the requirements of the regulations.
    - 1.8.1.1 A field evaluation label and report or letter issued by a nationally recognized testing laboratory verifying that the specific material, equipment, or method of construction meets the identified standards or has been tested and found to be suitable for the intended use, shall be accepted by the appropriate subcode official as meeting the requirements of the above.
    - 1.8.1.2 Reports of engineering findings issued by nationally recognized evaluation service programs such as, but not limited to, the Building Officials and Code Administrators (BOCA), the International Conference of Building Officials (ICBO), the Southern Building Code Congress International (SBCCI), the International Code Council (ICC), and the National Evaluation Service, Inc., shall be accepted by the appropriate subcode official as meeting the requirements of the above.
  - 1.8.2 The <u>New Jersey Department of Community Affairs</u> has confirmed that technical evaluation reports, from any accredited entity listed by <u>ANAB</u>, meets the requirements of item the previous paragraph, given that the listed entities are no longer in existence and/or do not provide *"reports of engineering findings"*.
- 1.9 **Approved by the Code of Federal Regulations Manufactured Home Construction and Safety Standards:** Pursuant to Title 24, Subtitle B, Chapter XX, <u>Part 3282.14</u><sup>47</sup> and <u>Part 3280</u>,<sup>48</sup> the Department encourages innovation and the use of new technology in manufactured homes. The design and construction of a manufactured home shall conform to the provisions of Part 3282 and Part 3280 where key approval provisions in mandatory language follow:
  - 1.9.1 *"All construction methods shall be in conformance with accepted engineering practices."*
  - 1.9.2 "The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur."
  - 1.9.3 "The design stresses of all materials shall conform to accepted engineering practice."





- 1.10 **Approval by US, Local, and State Jurisdictions in General:** In all other local and state jurisdictions, the adopted building code legislation states in pertinent part that:
  - 1.10.1 For <u>new materials</u> that are not specifically provided for in this code, the <u>design strengths and permissible</u> <u>stresses</u> shall be established by tests.<sup>49</sup>
  - 1.10.2 For innovative <u>alternatives</u> and/or methods of construction, the building official shall accept <u>duly</u> <u>authenticated reports</u> from <u>approved agencies</u> with respect to the quality and manner of use of <u>new</u> <u>materials or assemblies</u>.<sup>50</sup>
    - 1.10.2.1 An <u>approved agency</u> is *"approved"* when it is <u>ANAB ISO/IEC 17065 accredited</u>. DrJ is in the <u>ANAB</u> <u>directory</u>.
    - 1.10.2.2 An <u>approved source</u> is *"approved"* when an <u>RDP</u> is properly licensed to transact engineering commerce. The regulatory authority governing approved sources is the <u>state legislature</u> via its professional engineering regulations.<sup>51</sup>
  - 1.10.3 The <u>design strengths and permissible stresses</u> of any structural material...shall conform to the specifications and methods of design of accepted engineering practice performed by an <u>approved</u> <u>source</u>.<sup>52</sup>
- 1.11 **Approval by International Jurisdictions:** The <u>USMCA</u> and <u>GATT</u> agreements provide for approval of innovative materials, designs, services, and/or methods of construction through the <u>Agreement on Technical</u> <u>Barriers to Trade</u> and the <u>IAF Multilateral Recognition Arrangement</u> (MLA), where these agreements:
  - 1.11.1 State that <u>conformity assessment procedures</u> (i.e., ISO/IEC 17020, 17025, 17065, etc.) are prepared, adopted, and applied so as to grant access for suppliers of like products originating in the territories of other Members under conditions no less favourable than those accorded to suppliers of like products of national origin or originating in any other country, in a comparable situation.
  - 1.11.2 **Approved:** The <u>purpose of the MLA</u> is to ensure mutual recognition of accredited certification and validation/verification statements between signatories to the MLA and subsequently, acceptance of accredited certification and validation/verification statements in many markets based on one accreditation for the timely approval of innovative materials, designs, services, and/or methods of construction.
  - 1.11.3 ANAB is an <u>IAF MLA</u> signatory where recognition of certificates, validation, and verification statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA, with the appropriate scope, shall be approved.<sup>53</sup>
  - 1.11.4 Therefore, all ANAB ISO/IEC 17065 duly authenticated reports are approval equivalent.<sup>54</sup>
- 1.12 Approval equity is a fundamental commercial and legal principle.<sup>55</sup>
